Corporate Membership Program

A Corporate Membership in the Mount Vernon Rotary Club consists of at least one management individual and up to three employees within the same company. A Senior Officer (the Chairman, CEO, President or COO) becomes an Executive Member; attending as their schedule permits and pays for meals with regular participation in the Club's business and activities. The Executive Member selects the candidates in his/her organization to fill the active membership role for the corporation, subject to the candidates satisfying the criteria for membership of all Rotarians.

This program allows the Executive member to gain all of the benefits of a Rotary membership, yet work participation into their schedule as they are able.

Financial Investment: Dues are \$500 a year and invoiced annually. Active members must also pay their luncheon expense at \$9 per week directly to the Alcove.

A one-time initiation fee of \$60 will apply.

This is a savings of \$280 the first year and \$100 every year after compared to the standard membership program!!
